1. CALL TO ORDER

Chair, Rhonda Schumm, called the meeting to order at 7:00 pm.

5. Board Report

• Trustee Kilduff shared the 2016-2017 community report with attendees and invited comments from parents. At the February 23, 2017 Board Meeting, the Board passed By-Law No. 1-17, Rearrangement of the Electoral Wards and Trustee(s) to be Elected to Each Ward. Wards will be reduced from six (6) to five (5) and numbers of trustees elected to each ward will be adjusted. Board policies were reviewed on February 23, 2017.

6. Discussion Items

• The leadership of CoSC (Future Areas of Interest for Presentations or Information)
ASCA has resources including presentations on subjects related to school councils. Chair Schumm and
Trustee Kilduff encouraged school council members to utilize resources at ASCA and answered questions
surrounding school council by-laws and operating procedures.

Associate Superintendent Johnston recommended that school councils file their by-laws and other documents centrally at Center for Education. School councils are responsible for ensuring completeness of their documentation and making documents available to the public.

There was discussion around relationships and differences between school councils and school fundraising foundations.

• Inclusion: Perceptions and Realities

Dr. McConnell presented graphs explaining the past deficit-based model and the current strength-based model of special education. In the past deficit-based methodology, students were assessed for what they cannot do to qualify for special education, which was associated with several downsides including students being labelled.

There was discussion around an ASCA motion regarding increasing monitoring and assessments in special education in Alberta, which will be presented for voting in the 2017 Annual General Meeting (AGM).

• Truth and Reconciliation

Chair Schumm and Trustee Kilduff underlined the importance of school councils' participation in the AGM and the significance of their impact on education through ASCA.
