
Prescott Current Attendance Area


Prescott Learning Centre: Projected Enrolment

Recommendation A: Option 1-3

Addressing projected space challenges at Prescott Learning Centre (PLC) and declining enrolment at Parkland Village School

(Pages 9-12 in the Attendance Area Review)

Suggested Change: Option 1

 Converting Parkland Village School to a K - 6 School.





Rationale:

- Addresses projected space challenges at Prescott
 Learning Centre by decreasing the number of students
 designated to Prescott
- Utilizes available space at Parkland Village School
- Addresses declining enrolment at Parkland Village
- Prescott's enrolment will increase in the coming years with development in new growth areas north, northwest and immediately



Recommendation A: Option 2



Suggested Change: Option 2

• Redirect Parkland Village School students to Greystone Centennial Middle School.

Not being considered



Rationale:

- This scenario would have significant ongoing transportation costs
- Redirecting students from PLV to Greystone increases
 Greystone's capacity to 97%



Recommendation A: Option 3



Suggested Change: Option 3

 Redirect Parkland Village School students to Woodhaven School instead of Prescott Learning Centre (PLC)

Explore Further



Rationale:

- Addresses projected space challenges at Prescott
 Learning Centre
- Increases enrolment and utilization rate at Woodhaven Middle School
- Provides necessary capacity at Prescott Learning Centre for new neighborhoods in the PLC attendance area



Recommendation K East Spruce Grove - Growth Area Designation and New School



Suggested change:

Pre-designate parts of Pioneer Land and East Pioneer around the existing neighbourhoods of, Tonewood, Fenwyck and Easton to Brookwood and Woodhaven. Request a new school in Tonewood.


Rationale:

Considerations for Potential Attendance Area Exceptions

- Do we allow all 5 9 students to finish up at Prescott Learning Centre before moving?
- Do we allow just current Grade 7 9 (Junior High) students to finish up at Prescott Learning Centre?
- Is it economically sustainable to increase the number of buses to accommodate bus routes that run Parkland Village to Prescott Learning Centre and Woodhaven Middle School?
- Will School-of-Choice applications and fees apply should families wish to stay at Prescott Learning Centre?
- Would School-of-Choice fees no longer apply to those family that live in this area and currently attend Woodhaven Middle School already?

Next Steps:

- Survey will be sent to all Prescott Learning Centre families and staff
- Administration continues to collect information on this and all recommendations for the Board's consideration
- Survey/meet with potentially impacted students (age appropriate)
