



## AP 178 - APPENDIX A: FAIRNESS AND SAFETY IN SPORT CONFIRMATION FORM

### PARKLAND SCHOOL DIVISION

In accordance with the *Fairness and Safety in Sport Act* that came into effect on September 1, 2025, this confirmation form is required under the Government of Alberta's *Fairness and Safety in Sport Act* and associated Fairness and Safety in Sport Regulation. Under this legislation, athletes 12 and older wishing to participate in a female-only league (team), class (this does not include physical education class) or division of a relevant sport, must submit a signed Fairness and Safety in Sport confirmation form prior to participation.

The purpose of this confirmation is to confirm your child athlete's eligibility for participation in a female-only league (team), class or division of a relevant sport under the provincial legislation. This requirement applies to athletes aged 12 and older wishing to participate in a female-only league (team), class or division of a relevant competitive sport.

This form is to be completed by the parent/legal guardian and be returned to the school. Once the school receives the signed confirmation form for your child, this form will support all future participation in activities outlined under the *Fairness and Safety in Sport Act* at a Division school. To support this the confirmation form will be retained on your child's school record.



An athlete who is 18 years of age or older or an independent student, should complete the confirmation form on their own behalf.
